<p>Claire Leaney provided an overview of the Let’s Get Going Together physical activity conference held in March which was attended by over 80 representatives from the sport and health sectors. The Sport and Physical Activity Alliance (SPAA) would be looking at the outcomes of the conference and developing an action plan at its next meeting. <p>Housing - Kathy Farr reported that a supported housing information network exchange (SHINE) event is to be held on 3 July at BDBC Civic Offices, and that new outreach service providers have now started their contract in the borough</p> <p>Cultural sector - Flis Pitman noted that the Anvil is developing schools arts projects focusing on anxiety and dementia</p> <p>Southern Health – Sharon Hargreaves noted that a new health visiting service has been set up with Barnados</p> <p>St Michaels Hospice – Julie Spreadbury reported that the hospice is looking at the choices for palliative care that people can access to support them to die at home; the hospice is also running day sessions including support for managing breathlessness</p>	

<p>CCG – Paul Davey noted that North Hants CCG is to work more collaboratively with 3 other CCGs and align more closely with Hampshire wide communications. CCG is also focusing on frailty pathways and aiming for an event in October to change perceptions.</p> <p>Children, Young People and Families Partnership – June Balcombe reported that the Strategic CYPF group has approved the framework for a School's Mental Health project; the operational group now needs to plan delivery involving teachers, mental health practitioners, and pupils in peer support networks and will be seeking grant funding. BDBC has also prioritised resources for children, young people and families in its Community Development team and will be supporting communities to facilitate delivery</p> <p>Mental Health Alliance – Jess Berry reported that some service user representatives will attend future Alliance meetings</p> <p>Quit4Life – Gail Stringer highlighted work that is being done by the Q4L service at Basingstoke Hospital with inpatients and with Southern Health health visitors</p> <p>Public Health – Kate Donohoe reported that the Joint Strategic Needs Assessment is being updated and would be available in summer 2017 with web-based functionality to drill into data.</p>
